Council Chair Houchens noted we will be addressing the CVCMLS.com platform upgrade in 2023. CVCMLS subscriptions are up; currently at 142 users.

Staff reviewed the Strategic Plan and its impacts on the MLS Rules & Regulations Group.

New Business

The Group was asked to affirm a recommendation for lockbox system set-up related to reciprocity. After discussion the following **MOTION** was **MADE**, **SECONDED**, and **APPROVED**: The MLS Group recommends to the board that CAAR allow full reciprocity, as defined by Sentrilock*, to those Associations which have access to our MLS data, specifically compensation, showing instructions, and agent only remarks.

* Definition of Full Reciprocity: All Agents are automatically authorized to access lockboxes and the Association Administrator of the primary region is allowed to grant and revoke access for their Agents to the reciprocal region. For example; Association A and Association B share Full Reciprocity. The Agents in Association A can use their SentriKey Mobile App to access the lockboxes in Association B and vice versa. The Association Administrator of Association A can grant or revoke their Agent's accesses to Association B.

During the April meeting, the Group agreed they will address their decision about reciprocity for all other Virginia Sentrilock users for which we do not have access to compensation information, showing instructions, and agent remarks in our MLS platform.

Vice Chair Savage asked about differences between the rules and regulations of CAAR and Bright. Staff was tasked to obtain a copy of the Bright MLS rules and regulations.
